**ARTICLES OF ORGANIZATION
OF

The undersigned, Keith Miller, a natural person competent to contract and a member of Shine on Living, LLC, hereby presents these Articles of Organization as the Articles of Organization of Shine on Living, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Shine on Living, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSE AND POWERS

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

ARTICLE V - REGISTERED OFFICE AND AGENT

The registered office of the Company is 59 Quiet Cove, Freeport, FL 32439 and the name of the registered agent at that address is Keith Miller.


ARTICLE VI - MANAGEMENT


