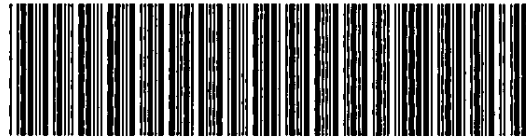



The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 605 of the Florida Statutes, as follows:

ARTICLE I

The name of this limited liability company is AGORA TECHNOLOGIES LLC (the "Company").

ARTICLE II

The mailing and street address of the principal place of business of the Company are 21857 Disturbed Pine Road, Cudjoe Key, Florida 33042.

ARTICLE III


