ARTICLES OF ORGANIZATION

OF

PURE AND SIMPLE HEALTH, LLC

- 1. <u>Name.</u> The name of this limited liability company is **PURE AND SIMPLE HEALTH, LLC**, a Florida limited liability company (the "<u>Company</u>"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
- 2. <u>Duration.</u> The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
