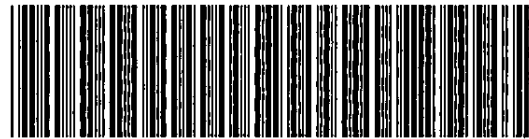




**ARTICLE VI – TERMINATION OF EXISTENCE**



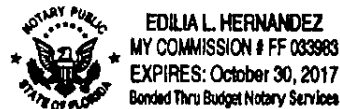
