# ARTICLES OF ORGANIZATION OF V V T C, LLC

The undersigned, acting as an authorized representative of the initial member(s) of the above captioned Limited Liability Company, under the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

### <u>ARTICLE I</u> NAME & ADDRESS
