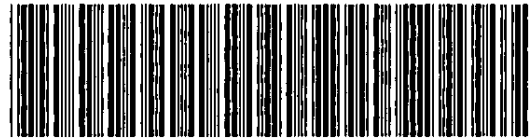

PURPOSE

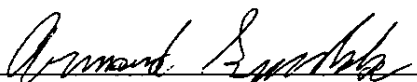
The purpose for which the Firm is organized is to conduct any and all lawful business.

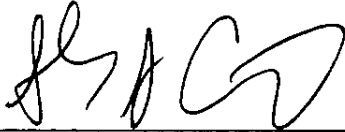
