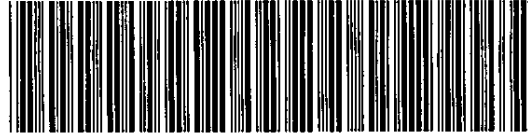



2. This amendment is filed to change the name of this entity from "Nicobine, LLC" to "SRQ Patent Holdings, LLC"


