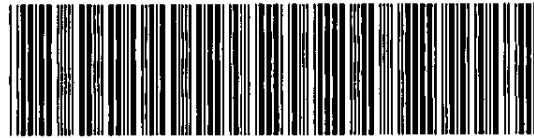




1. The name of the Florida Profit Corporation immediately prior to the filing of this Certificate of Conversion is **WUBZY SERVICES INC.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **WUBZY SERVICES LLC**, ("Company").

ARTICLE 2 - ADDRESS




