Principal Office

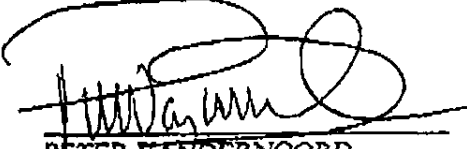

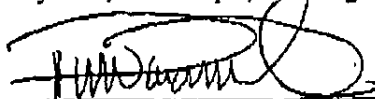
