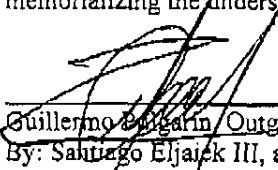
3. The foregoing Amendment was approved by resolution of a majority of the Members occurring on February 25<sup>th</sup>, 2015.
