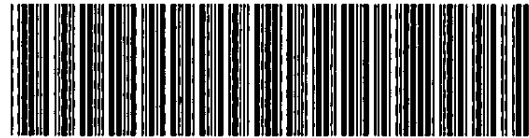



ARTICLE I
NAME

The name of this limited liability company shall be Michael Pearl Productions, LLC.


