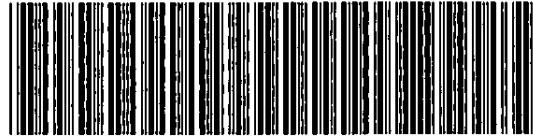



ARTICLES OF ORGANIZATION OF  
CENTER STREET HOUSE, LLC

The undersigned, desiring to form a limited liability company under and pursuant to §605.0201, Florida Statutes, does hereby certify as follows:

- FIRST: The name of said limited liability company shall be Center Street House, LLC.
- SECOND: Center Street House, LLC shall exist in perpetuity.
- THIRD: Copies of the Operating Agreement of Center Street House, LLC may be obtained from the Manager at 2655 LeJeune Road, Suite 1101, Coral Gables, Florida 33134, which is the place in the State of Florida where the principal office of the limited liability company is located. The mailing address of Center Street House, LLC shall be 2655 LeJeune Road, Suite 1101, Coral Gables, Florida 33134.
- FOURTH: The purposes for which Center Street House, LLC is formed are:
- A. To trade, buy, lease, improve, invest and sell real estate, personal property, to invest in stocks, bonds and any and all other securities, and to participate in buying, selling and trading of the same; to invest in various business ventures and the purchasing and holding of the equity interests therein; and to loan, borrow or raise monies for any of the purposes of the limited liability company
  - B. To engage in such other lawful acts or activities for which limited liability companies may be formed under §605.0108, Florida Statutes.
- FIFTH: The maximum number of ownership units which Center Street House, LLC is authorized to have outstanding is one thousand (1000), all of which shall be identical units, and each of which shall represent the ownership of that percentage of the total units outstanding at any time as is the equivalent of the ratio in which one (1) is the numerator and the total units outstanding is the denominator.
- SIXTH: Center Street House, LLC desiring to organize under the laws of the State of Florida as a limited liability company has designated its initial registered office at 2655 LeJeune Road, Suite 1101, Miami-Dade County, Coral Gables, Florida, 33134 and has named Charles S. 
EIGHTH: The business of this limited liability company shall be conducted by its Manager who shall be elected by the Members and who shall be elected in accordance with the Operating Agreement.
