**ARTICLES OF ORGANIZATION
OF
BLUE BRIDGE PRODUCTIONS, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 605.0201, Florida Statutes, as the same may from time to time be amended (the "Act").

ARTICLE I - NAME

The name of this limited liability company is "BLUE BRIDGE PRODUCTIONS, LLC" (the "Company").

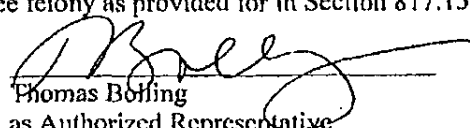
ARTICLE IV - MANAGEMENT OF THE COMPANY
