**ARTICLES OF ORGANIZATION
OF
SCIENTIFIC AERIAL SERVICES, LLC**

1. Name. The name of this limited liability company is **SCIENTIFIC AERIAL SERVICES, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

6. Purpose; Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
