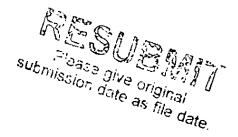

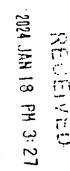

Merger between MAH VENICE INVESTMENTS LLC, a Florida limited liability company ("Surviving Entity"), S.J.T. VENICE, LLC, a Florida limited liability company ("Merging Entity"). This Merger is being effected under this Plan of Merger ("Plan") in accordance with Section 605.1022 of the Florida Revised Limited Liability Company Act ("Act").

- (A) <u>Description of Merging Entity.</u> The merging entity is as follows:
 - (i) S.J.T. VENICE, LLC, a Florida limited liability company ("Merging Entity").
- (B) <u>Description of Surviving Entity</u>. The surviving entity of the merger is as follows:
 - (i) MAH VENICE INVESTMENTS LLC, a Florida limited liability company ("Surviving Entity").
- (C) Effect of Merger. On the Effective Date of the Merger ("Effective Date"), the Merging Entity shall be merged with and into the Surviving Entity. The membership interests, rights to acquire interests, securities, obligations, money, and property in the Merging Entity shall become property of the Surviving Entity. The separate existence of the Merging Entity shall cease at the Effective Date and the existence of the Surviving Entity shall continue unaffected and unimpaired with all of the rights, privileges, immunities, and franchises of a public as well as a private nature and subject to all of the duties and liabilities of a limited liability company organized under the laws of the State of Florida. On the Effective Date, the Surviving Entity shall be responsible and liable for all liabilities and obligations of the Merging Entity.
