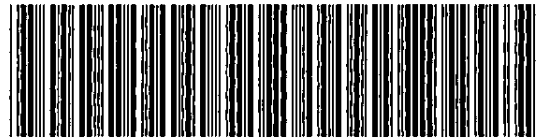

**ARTICLES OF ORGANIZATION
OF
PCB 2, LLC**

The undersigned, under the provisions of Chapter 605 of the Florida Statutes, the Revised Limited Liability Company Act, (hereinafter referred to as the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, does set forth the following:

ARTICLE I
Name.

The name of the limited liability company is PCB 2, LLC (hereinafter referred to as the "Company").

ARTICLE II
Period of Duration.

Unless earlier terminated under the Act or the Company's Operating Agreement, the period of duration of the Company shall be perpetual.

ARTICLE III
Purpose.

The purpose for which the Company is organized is to engage in any and all business and activities permitted by the Act and any other applicable laws of the State of Florida, including the investment, development and leasing of real property. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of the laws of the State of Florida.

ARTICLE IV
Address of Place of Business.

ARTICLE V
Registered Agent.

ARTICLE VI
Capital Contributions.

Contributions to the capital of the Company shall be made by the members, in the manner prescribed by the Company's Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

ARTICLE VII
Members.

The Company shall have at least two (2) members and may admit additional members as provided in the Company's Operating Agreement.

ARTICLE VIII
Management.

The Company is to be managed by the member who is designated, appointed, or elected to act as the managing member in accordance with the Operating Agreement of the Company.

The managing member who is designated as such by the member(s) shall carry out and further the decisions and actions of the member(s) made in accordance with the Company's Operating Agreement and shall be authorized to execute on any and all reports, forms, instruments, documents, papers, writings, agreements, and contracts, including but not limited to deeds, bills of sale, transfers, leases, promissory notes, mortgages, security agreements, and any other type or form of document by which property or property rights of the Company are transferred or encumbered or by which debts and obligations of the Company are created, incurred, or evidenced, which are necessary, appropriate, or beneficial to carry out or further such decisions or actions.

In accordance with the Act, the execution of this document constitutes an affirmation under penalties of perjury that the facts stated herein are true.

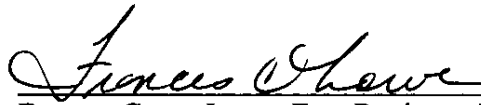
CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/ REGISTERED OFFICE.
