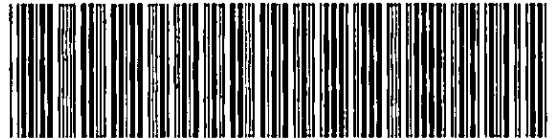

Peter J. Ghiloni and Raymond L. Creasman are the sole Members of the Company and are the persons appointed to wind up the activities and affairs of the Company.


