Called your office and was told to send this.

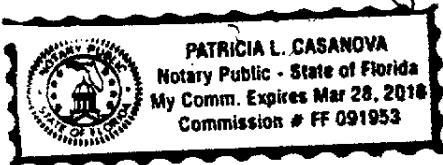
