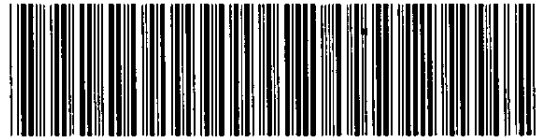

The Articles of Organization of the Company were filed on November 17, 2014 and were assigned Florida document number L14000177875.


The amendment to the Articles of Organization of the Company is as follows:
