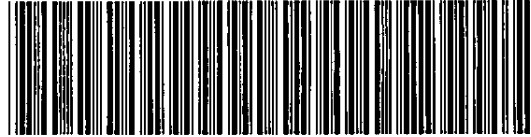

FIRST: This Amended Restated Articles of Organization amends and restates the Articles of Organization of Total Asphalt Services, LLC.

The mailing address and street address of the principal office of the Company shall be as follows:

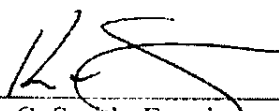

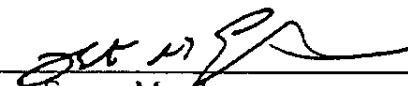
