In accordance with Florida Statutes, Chapter 605, the undersigned executes these Articles of Organization for the purpose of organizing a limited liability company upon the following terms and conditions:

LLC.

A. The name of the limited liability company is **JOEL DIPA**,

B. The street address of the principal office of the limited liability company is **111 BEVERLY DRIVE, WINTER HAVEN, FL 33884.** The mailing address is **the same**.

C. The name and street address of the limited liability company's initial registered agent for service of process in the state is **MOHAMED H. ISLAM, 111 BEVERLY DRIVE, WINTER HAVEN, FL 33884**.

D. The limited liability company will be managed by MOHAMED H. ISLAM and NASRIN ISLAM, 111 BEVERLY DRIVE, WINTER HAVEN, FL 33884.

E. In addition to the powers authorized by the laws of the State of Florida for limited liability companies, the general nature of the business or businesses to be transacted, and which the limited liability company is authorized to transact, shall be as follows:
