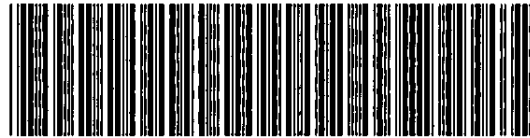

**ARTICLES OF ORGANIZATION OF
JEWER FAMILY HOLDINGS, LLC,
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned (the "Member") acting as the organizer of Jewer Family Holdings, LLC under the Florida Revised Limited Liability Company Act (the "Act"), Chapter 605, Florida Statutes adopts the following Articles of Organization.

**Article 1
Name**

The name of the limited liability company is Jewer Family Holdings, LLC (the "Company").

**Article 2
Period of Duration**

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

**Article 3
Purposes, Powers and Capital Contributions**

- A. Purposes. The Company is organized for, and may engage in, any lawful purposes.
- B. Powers. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 605, Florida Statutes as the same may be amended from time to time.
- C. Capital Contributions. The Members shall make contributions from time to time, as required by the Operating Agreement adopted by the Company.

**Article 4
Member-Managed Limited Liability Company**

The overall management and control of the business and affairs of the Company shall be vested in its members, as provided in these Articles of Organization and section 605.0407 of the Act. Any and all action by the Company shall require the vote of members holding a majority interest in the Company.

Persons Authorized to Manage and Control the Limited Liability Company

Continuity of Business

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or on the occurrence of any other event that terminates the continued membership of a Member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all remaining Members of the Company.

Article 12
Adoption of Operating Agreement

The Company shall adopt an Operating Agreement for the Company, which Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization, or Chapter 605, Florida Statutes.
