# ARTICLES OF ORGANIZATION

## OF

# **BRYSTIN'S MOVING LLC**

#### **ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT**




#### **ARTICLE 9 - MANAGEMENT**
