The undersigned, for the purpose of amending and restating the original Articles of Organization of 3786 Associates, LLC, a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as filed with the Florida Department of State on November 18, 2014, hereby make, acknowledge, and file the following Amended and Restated Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be **3786 ASSOCIATES, LLC** (the "Company").

**ARTICLE II - ADDRESS**

The mailing address and initial principal office of the Company shall be 3786 Mercantile Avenue, Naples, Florida 34104.

**ARTICLE III - DURATION**

The Company commenced its existence on the date the original Articles of Organization were filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Amended and Restated Articles of Organization or in the Company's Operating Agreement.

**ARTICLE IV - REGISTERED AGENT**

**ARTICLE V - MANAGEMENT**

The Company shall be manager-managed in accordance with the Operating Agreement adopted by the Members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the law or these Amended and Restated Articles of Organization. 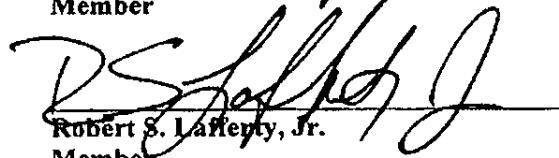

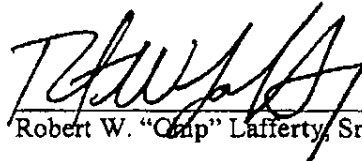
