

**AMENDED ARTICLES OF ORGANIZATION**  
**OF**  
**T'S HOUSE OF DOGS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges and files these Articles of Organization.

**ARTICLE I - NAME**

The name of the Limited Liability Company shall be T'S HOUSE OF DOGS, LLC ("Company").

**ARTICLE II - ADDRESS**

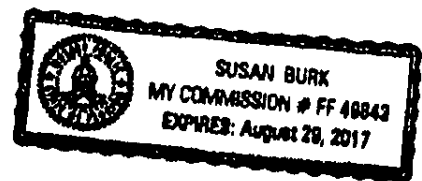
