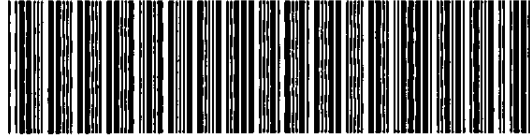

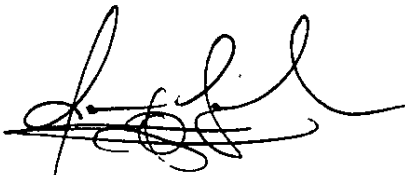

Article I. Name

Article IV. Management

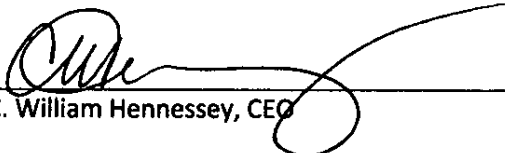

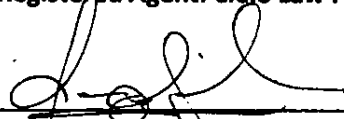
