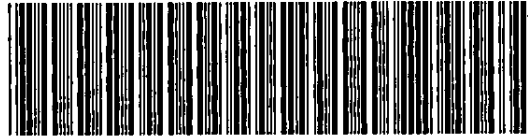

## **ARTICLES OF ORGANIZATION**

**OF**

### **EESOME EQUESTRIAN LLC**

I hereby file these Articles of Organization as the authorized representative of the member of the limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida.

#### **ARTICLE I**

##### **NAME**

The name of the limited liability company to be formed hereunder is "Eesome Equestrian LLC" (the "Company").

#### **ARTICLE II**

The Company may engage in the transaction of any or all lawful business for which a limited liability company may be formed under the laws of the State of Florida.


**ARTICLE VII**



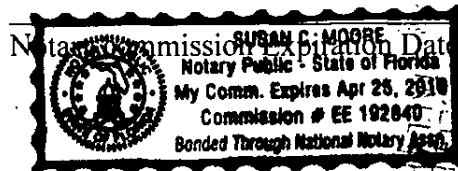
