ARTICLE I

ARTICLE VII



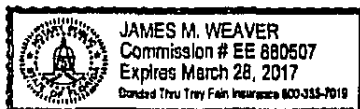
