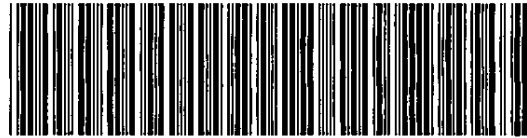



**ARTICLE VI - Management:** The Company shall be managed by its sole member.

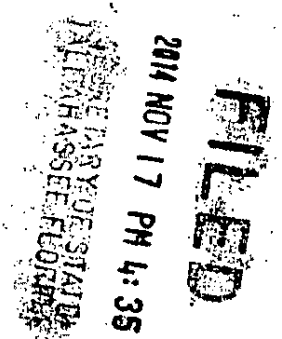


