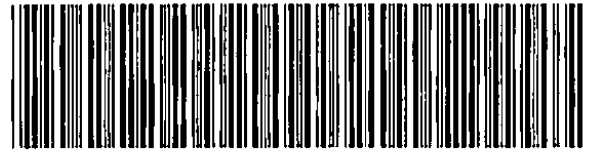



RESOLVED, it would be in the best interests of the Company and its sole member for the Company to be dissolved.


