Address

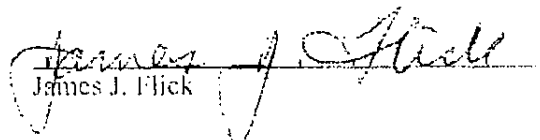

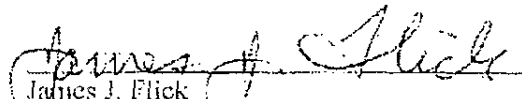
