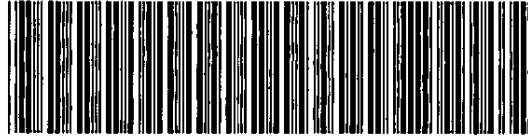

ARTICLES OF ORGANIZATION OF NATIVE ANGLER FISHING CHARTERS, LLC

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company

ARTICLE I

NAME AND MAILING ADDRESS & STREET ADDRESS OF PRINCIPAL OFFICE

The name of the limited liability company shall be NATIVE ANGLER FISHING CHARTERS, LLC, [hereinafter the "Company"] and its principal office's street address shall be 609 N. Mayo Street, Crystal Beach, FL 34681 and its mailing address shall be P.O. ARTICLE II
