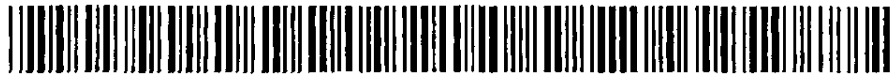

ARTICLES OF ORGANIZATION

OF

GF STREET, LLC

The undersigned desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 605, Fla. Stat., adopts the following Articles of Organization:

ARTICLE I - NAME
