



The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 605, Florida Statutes, as follows:

ARTICLE I

The name of this limited liability company is Aitella Holdings LLC (the "Company").

ARTICLE II

The mailing and street address of the principal place of business of the Company are 702 Douglas Drive, Jupiter, Florida 33458.

ARTICLE III

ARTICLE IV




