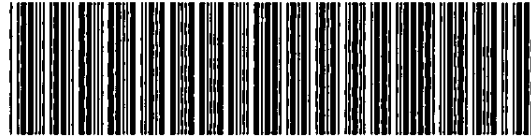

FOR

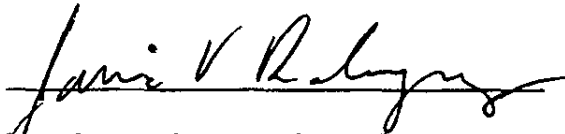
