I, Cyndi R. Wilson, am over eighteen years of age and fully able to testify upon personal knowledge to the facts stated herein and state under oath as follows:

- As reflected in Filing Document Number L13000034924, I previously served as the Registered Agent, an Authorized Person, and Managing Member of a limited liability company called "Eagle Ground Executive Transportation of Palm Beach, LLC" (referred to hereafter as the "Dissolved Company") until such entity was administratively dissolved on September 26, 2014.

- The Dissolved Company has no assets or money of its own to pay the reinstatement fee required by the Florida Department of State and I do not and would not consent to any action the sole other member, Abdelkahir Benjarara, may take to reinstate the Dissolved Company.

- The Dissolved Company was formed without an operating agreement, any written agreement as to contributions, ownership, and/or management and for that reason is currently deadlock with respect to any further activity.

- I have been doing business as Eagle Ground Executive Transportation of Palm Beach for years and that name is associated in Florida's transportation industry with me and limo and/or transportation services supported and approved by me. I am the sole owner of the fictitious name, "Eagle Ground Executive Transportation of Palm Beach", under Fictitious Name Registration Number G07131900148 and was previously under Fictitious Name Registration Number G01365900052 from December 21, 2001 to December 31, 2006.

- The fictitious name, "Eagle Ground Executive Transportation of Palm Beach" does not belong to the Dissolved Company and the Dissolved Company no longer has my consent to use this fictitious name or to otherwise associate the quality of its services with me or my business (dba) name.

I understand that I am swearing or affirming under oath to the truthfulness of the facts and claims asserted in this affidavit and that the punishment for knowingly making a false statement includes fines and/or imprisonment.
