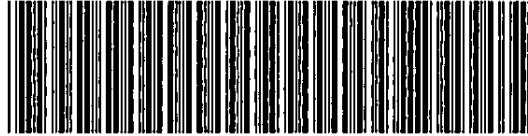



In accordance with the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), the undersigned, being authorized to execute and file these Articles of Organization, hereby certifies effective as of November 20, 2014, that:

**ARTICLE I – NAME**

The name of the limited liability company is "Nurse Mary on Call, LLC" (the "Company").

**ARTICLE II – ADDRESS**

ARTICLE VII - MEMBERS RIGHTS TO CONTINUE BUSINESS

The right of the remaining Members of the Company to continue the business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company shall be specified in the Operating Agreement.

ARTICLE VIII - LIMITATION ON AGENCY AUTHORITY OF MEMBERS

Pursuant to the Company's Operating Agreement, no Member of the Company shall be an agent of the Company solely by virtue of being a Member, and no Member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a Member. The Operating Agreement may, however, specify that its President or its Chief Executive Officer shall have authority to incur debt or contractual liability on behalf of the Company.


