**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION  
OF

Pursuant to the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, **2401 SUNSHINE LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

SECOND: The Company's Articles of Organization are hereby amended by deleting Article I of the Articles of Organization in its entirety, and replacing it with the following new Article I:


**"ARTICLE I. NAME**
