
FOURTH: There are no amendments to the acquired limited liability company's public organic record approved as part of the plan of interest exchange.

FIFTH: The plan of interest exchange was approved by the acquiring entity that is a party to the interest exchange in accordance with the organic laws in its jurisdiction of formation.


