## ARTICLES OF ORGANIZATION

### HESSLER'S HOLDINGS, LLC (Manager Managed)

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I NAME AND PRINCIPAL OFFICE

The name of the Limited Liability Company shall be HESSLER'S HOLDINGS, LLC ("Company"). The mailing address and street address of the principal office of the Company is: 1245 Shadow Lane, Fort Myers, Florida 33901.

#### ARTICLE II DURATION

The Company shall commence its existence upon the filing of these Articles of Organization, and its existence shall be perpetual unless the Company is dissolved as provided in these Articles of Organization.

#### ARTICLE III PURPOSES AND POWERS

The general purpose for which the Company is organized is to operate as a holding company for assets owned by Hessler's, Inc., a dissolved Florida corporation, and to conduct other lawful activities incident to same. The Company shall further be authorized to transact any lawful business for which a Limited Liability Company may be organized under the laws of the State of Florida. 
ARTICLE IV
