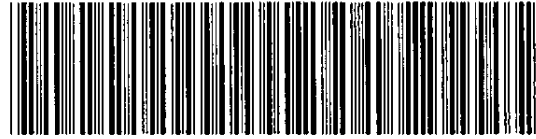

The Articles of Organization of the Company were filed on December 11, 2014 and were assigned Florida document number L14000189431.

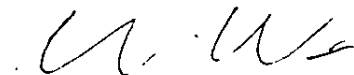
The amendment to the Articles of Organization of the Company is as follows:
