

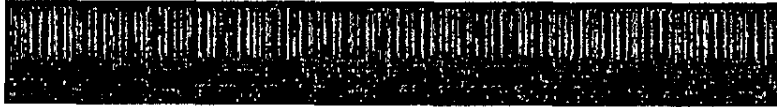

The name of the limited liability company is Kimball Key, LLC.


ARTICLE II. ADDRESS


ARTICLE IV. MANAGEMENT OF COMPANY
