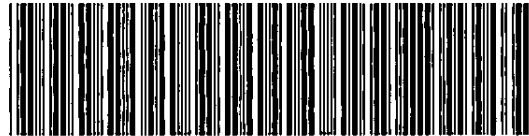

Name

Continuation of Business

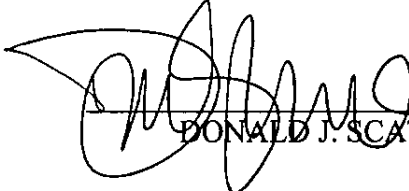

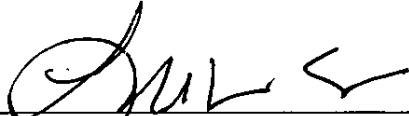
