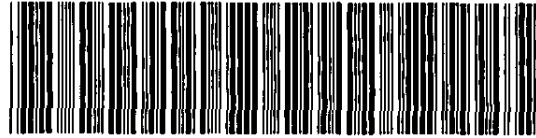

The Company is to be manager-managed.

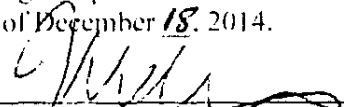
ARTICLE V - Purpose:

IN WITNESS WHEREOF, the undersigned, pursuant to laws of the State of Florida, has executed these Articles of Organization as of December 18, 2014.

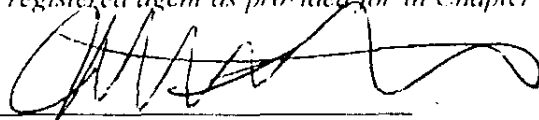
