OF

The mailing address and street address of the principal office of the Company is 16930 Juanita Ave, Unit G, Fort Myers, FL 33908.

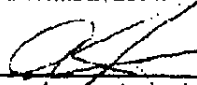
ARTICLE III - REGISTERED OFFICE/REGISTERED AGENT
