

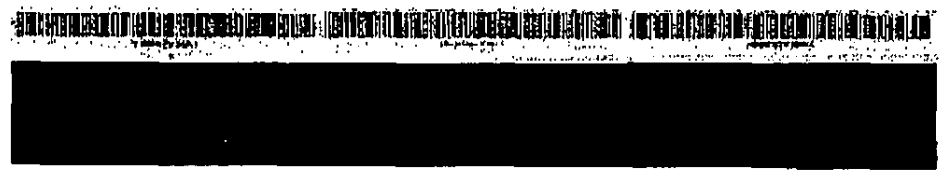

**ARTICLES OF ORGANIZATION
