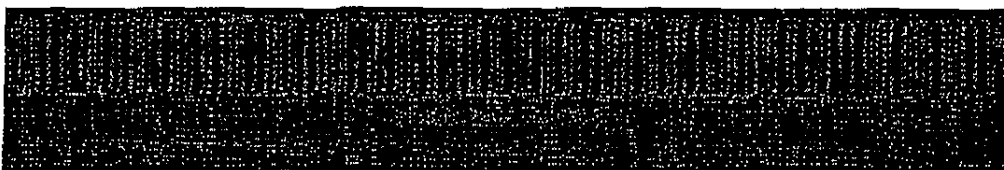

NEW MEMBERS**



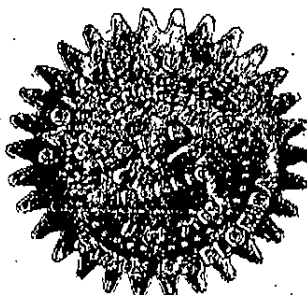
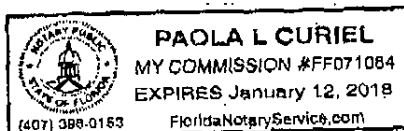
