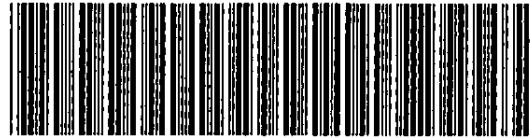

ARTICLES OF ORGANIZATION
OF
COMPLETE CLEAN GULF SERVICES, LLC

The undersigned pursuant to the provision of Chapter 605 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME:

The name of the Limited Liability Company is Complete Clean Gulf Services LLC.

2. PERIOD OF DURATION:

The period of duration of the Company shall not exceed the maximum term permitted under the Florida Limited Liability Company Act. The Company may be dissolved sooner, however, as provided in the Florida Limited Liability Act or the written Operating Limited Agreement to be executed by all of the Members of the Company. The effective date of the Liability Company shall be the date of filing.

3. PURPOSE:

The purpose for which the Company is organized is to provide professional cleaning services, power washing and home cleaning and to engage in any and all other businesses and activities permitted by the laws of the State of Florida. The Company shall have all of the powers vested in a limited liability Company organized and existing by virtue of such laws.

10. MANAGEMENT:

The management of the Company shall be reserved to the Members. In the event of the death of a Manager, the remaining Manager(s) shall serve until the next meeting of the Members and until a successor (if any is elected) for the deceased Manager is qualified.
