





I did not, directly or indirectly, file the Articles of Dissolution for Red Hawk Financial LLC dated March 31, 2015 that the State of Florida Division of Corporations represents was filed using my name, Aaron Taravella, nor did I authorize anyone to file any such document on my behalf, or use my name on any such filing.




