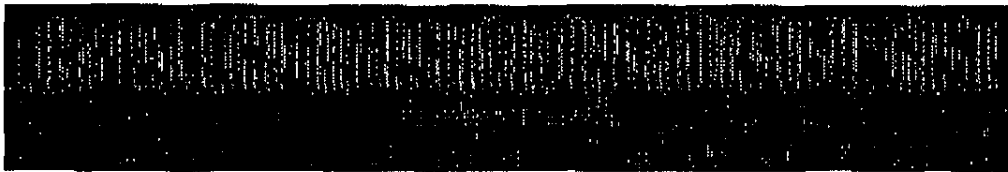

MANAGEMENT BY MEMBERS


The Company will be managed by one of its members.


